**Purpose:** Marine related coverages excluded under the CGL to provide Care, Custody & Control Coverage for the Property of Others, in this case, boats and boating equipment. This MOLL does not provide Protection and Indemnity (P&I Coverage).

**Limits:** The insured elects each coverage part and a separate limit for each coverage part. A separate premium applies to each coverage part. The per occurrence limits available are \$300,000, \$500,000 and \$1,000,000.
